## **Rule Change Proposals**

- 1) Add under treasurer duties the responsibility of filing taxes [B-Y, P-Y, LM-Y]-PASSED
- 2) Separate racking judge to be hired [B-Y, P-Y, LM-Y]-PASSED
- 3) Fix the conflict where a competitor can petition the board for an open spot for the State Show where they have made 50% of the required shows and pay \$50.00 to apply; where the NWGHA rules states 51% of shows [B-Y, P-Y, LM-Y]-PASSED
- 4) Running VP definition and add duties [B-N, P-N, LM-Y]- FAILED
- 5) Amend VP duties [B-Y, P-Y, LM-Y]- PASSED
- 6) Add to secretary duties to keep track of BOD votes where clarification is needed [B-Y, P-Y, LM-Y]—PASSED
- 7) Add rules that anytime the BOD needs to clarify an issue during the show season that said issue is automatically on the agenda to review during rule change proposals [B-N, P-N, LM-Y]—FAILED
- 8) Add the Federation pony rule [B-Y, P-Y, LM-Y]—PASSED
- 9) Define rule pecking order [B-N, P-N, LM-N)—FAILED
- 10) Constitution change on quorum [B-Y, P-Y, LM-Y]--PASSED
- 11) Change the Show Sheet to \$8 & \$10 for classes with a discount for pre-registration [B-Y, P-Y, LM-Y]—PASSED
- 12) Change the payback percentage to 80% [B-Y, P-Y, LM-Y]—PASSED
- 13) Clarify who votes on rule change proposals
  - a. Club reps only—[B-Y, P-Y, LM-Y]—PASSED
  - b. BOD—[B-N, P-N, LM-N]--FAILED
- 14) Remove B from Federation Rule to NWGHA rule [B-Y, P-Y, LM-Y]—PASSED

#### **New Business**

- What needs to happen to remove a judge—John Cordell was on a trial basis for pleasure but is not approved for pleasure in the future
- Dawn Schroeder—March show turned in points certification sheet, but was not received. Voted to allow her to receive points
- Laura Campbell—did not realize she needed to fill out her own points certification sheet. Voted to allow her to receive points
- Camden McMahon—13 on May 1<sup>st</sup> 2015, ran in the small-fry class, should have been in the youth. Decided that her shows count toward the 51% qualifying shows. Points only April-June count in youth classes
- Bailey Wilkey—Runner, showing walk/trot. Cannot run and walk/trot only, so her walk/trot points do not count
- Should put a sign in the office that lists all the State Show requirements. Bartow to look at creating.
