POINT KEEPER REPORT: Nikki V. as follows:

Points – problems and subsequent decisions of point questions/discrepancies were presented and settled as follows:

- April halter class Linda P. showed gelding halter, was apparently in pain, handed off to another exhibitor w/o changing back numbers. Judge apparently was aware/ok w hand off, as the horse had been shown to judge by Linda before she left arena. Problem - Judge card/booth record credited Rachael #, the only official record, and conflicts w NWGHA rule. Motion made to allow Linda to receive point by Sheri, 2nd by Jessica, VOTE: YES 5, NO 3, ABST. 1.
 - ***For future, Will need to clarify/update NWGHA bylaw for situations as this, during July/Aug rule review.
- 2. Donnie W. requesting board to consider allowing a 12&under runner (who has had to miss the March show(her 1st show) due to family health hardship), to qualify for any OPEN SLOTS left in the 12 & under division, but with making only 3 shows. Disussion of 51% (NWGHA rule), Federation rules, and the difficulty in making this exception with out making it for many others discussed. Motion to ALLOW her to qualify by Donnie, Seconded by Melissa. VOTE: YES 2, NO 5, ABSTAINED 2.
- 3. Correction to mis-applied points to Mom/daughter, (Laura and Lacey McKellar). Sheets were reviewed/corrected, and points correctly applied w/o need for vote.
- 4. Concern raised by Keri D. and Sheri F regarding Olivia Campbell, who 's Bartow SC check keeps getting sent back to NWGHA instead of their club receiving. Concern discussed over BCSC recognizing her as member, Cert sheets and check were done at OCTOBER SHOW. She will /should be a qualified rider. A MOTION made by Keri D asking BOARD to make note that she SHOULD BE SEEN AS QUALIFIED RIDER, if any conflict arises due to MIS-HANDLED CHECK, etc. Seconded by Sheri. VOTE: YES 7, ABSTAIN 1.
